

I. INTRODUCTION

- 1.1. Welcome to our site. Our website, www.c7traders.com (the “Website(s)” or “Site(s)” and includes reference to other websites that C 7 Traders operates) is operated by C 7 Traders. Please read the following website terms and conditions carefully, including our Privacy Policy (collectively, the “**Website Conditions**”) before using this Website and/or the Services (as defined below) so that you (the “**User**”, or “**you**”) are aware of your legal rights and obligations with respect to C 7 Traders and/or its related entities, affiliates and subsidiaries and the usage of our Website.
- 1.2. By accessing and using this Website and/or use of the Services, you hereby agree to be legally bound by these Website Conditions. If you do not accept these Website Conditions, please leave the Website and discontinue use of the Services immediately.
- 1.3. C 7 Traders reserves the right to change, modify, suspend or discontinue the whole or any portion of the Services or Website at any time. C 7 Traders may also impose limits on certain features or restrict your access to parts or the entire Services or Website without notice or liability.
- 1.4. C 7 Traders may from time to time vary or amend these Website Conditions by posting the amended Website Conditions on this Website. Any use of the Services after the amendment of these Website Conditions will be deemed to be acceptance of the amended Website Conditions by you. If you do not agree to the amended Website Conditions, you have the right to close your Account (as defined below) and/or cease using the Services.
- 1.5. Any rights not expressly granted herein are reserved.
- 1.6. The words “include” and “including” shall not be construed as having any limiting effect.
- 1.7. The headings in these Website Conditions do not have any legal effect nor shall they affect the construction of these Website Conditions in any way.

2. SITE AND SERVICES

- 2.1. C 7 Traders may offer one or more of the following services on the Website (each a “**Service**” and collectively the “**Services**”):
 - (a) a platform to perform Trading activities (the “**Platform**”);
 - (b) a social networking platform;
 - (c) e-mail alerts;
 - (d) third party economic news;
 - (e) marketing commentary videos; and
 - (f) any other features, links to other third party websites, materials, information, news, advertisements, listings, data, input, text, songs, audio, video, pictures, graphics, software, blogs, webcasts, podcasts, broadcasts, messages, software, comments, suggestions, ideas and other content (the “**Content**”) and applications that C 7 Traders may offer on or through the Website from time to time in its sole and absolute discretion.

3. USER ACCOUNT

- 3.1. Visitors to the Website acknowledge and agree that to access and use certain Services such as the Platform, you will be required to register an account (the “**Account**”). You become an Account holder by registering your identifying information on the Website. As an Account holder, you will have an account allowing you to access the Services reserved solely for Account holder.
- 3.2. You shall promptly notify C 7 Traders of any known or suspected unauthorised use(s) of your Account, or any known or suspected breach of security, including loss, theft, or unauthorised disclosure of your username and/or password. You shall be solely responsible for safeguarding and maintaining the confidentiality of your username and/or password.
- 3.3. C 7 Traders shall have no responsibility or liability whatsoever for any loss, damage, cost, expenses, or liabilities arising as a result of or in connection with the wrongful or fraudulent use of your username and/or password.
- 3.4. You shall provide C 7 Traders with accurate, complete, and up-to-date information in all required fields contained in the registration form. Failure to do so shall constitute a breach of these Website Conditions, which may result in the restriction, suspension or immediate termination of your Account by C 7 Traders at its sole and absolute discretion.
- 3.5. You agree that C 7 Traders reserves the right to change or re-assign usernames and/or passwords at its sole discretion by giving you notice. C 7 Traders shall not be liable in any way whatsoever for any loss, damage, cost or expense incurred by you as a result of such change or re-assignment.

4. CONDUCT USE CONDITIONS

- 4.1. You may not reproduce, modify, adapt, translate, publish, display, communicate, transmit, broadcast, podcast, webcast, distribute, sell, trade or exploit for any commercial or other purposes, any portion of, or any access to:
 - (a) any Service;
 - (b) the Website;
 - (c) any C 7 Traders Content except, to the extent permitted, with the prior written consent of C 7 Traders or unless expressly permitted in these Website Conditions; or
 - (d) any Third Party User Content except, to the extent permitted, with the prior written consent of C 7 Traders and the owner or licensee of the specific User Content.
- 4.2. Each time you submit Content to this Website, you have the right to submit the Content to this Website and that:
 - (a) you are the author of the Content; or
 - (b) the Content is not protected by copyright law; or
 - (c) you have the express permission from the copyright owner to post the Content on this Website; and
 - (d) you have the right to grant C 7 Traders the license set out in these Website Conditions; and
 - (e) the Content you submit does not violate these Website Conditions.
- 4.3. Without prejudice to the generality of the above, you agree not to reproduce, display or otherwise provide access to the Services, C 7 Traders Content, or Third Party User Content on another website or server, for example through framing, mirroring, linking, spidering, scraping or any other technological means (including any technology available in the future), without the prior written permission of C 7 Traders.
- 4.4. You may for your personal, non-commercial use:
 - (a) retrieve and display C 7 Trader’s Content on any compatible device owned by you;
 - (b) print a single copy of C 7 Trader’s Content on paper (but not photocopy them); and
 - (c) store such C 7 Trader’s Content in electronic form on a disk or on a mobile device owned by you (but not on any server or other storage device connected to a network).
- 4.5. You may not decompile, reverse engineer or otherwise attempt to discover the source code of any C 7 Traders Content available on the Website or through a Service under the specific circumstances expressly permitted by law or C 7 Traders in writing.

- 4.6. You undertake to comply with these Website Conditions, and such other notices or guidelines that may be posted on the Site by C 7 Traders from time to time (which are hereby incorporated by reference into these Website Conditions).
- 4.7. You undertake not to use any Service or C 7 Traders Content for any unlawful purpose, and to comply with all applicable laws and regulations, including without limitation, copyright law.
- 4.8. You undertake not to hack into, interfere with, disrupt, disable, over-burden or otherwise impair the proper working of the Site, Service or computer software, systems and servers hosting, operating, managing, providing or contributing to the Website and the Services (the “**Server**”), which shall include but not limited to denial-of-service attacks, spoof attacks, session hacking, sniffing, tampering, reverse engineering or reprogramming.
- 4.9. You undertake not use the Account of another Account holder at any time, whether with our without his/her prior permission.

5. RULES FOR ONLINE CONDUCT

- 5.1. You agree not to submit any Content that:
 - (a) contains vulgar, profane, abusive, hateful, sexually explicit language, epithets or slurs, text or illustrations in poor taste, inflammatory attacks of personal, sexual, racial or religious nature, or expressions of bigotry, racism, discrimination or hate;
 - (b) defamatory, threatening, disparaging, inflammatory, false, misleading, deceptive, fraudulent, inaccurate, or unfair; contains gross exaggeration or unsubstantiated claims, violates the privacy rights or right of publicity of any third party, is unreasonably harmful or offensive to any individual or community, contains any actionable statement, or tends to mislead or reflect unfairly on any other person, business or entity;
 - (c) unfairly interferes with any third party’s uninterrupted use and enjoyment of the Services;
 - (d) advertises, promotes or offers to trade any goods or services, except in areas specifically designated for such purpose;
 - (e) is intended primarily to promote a cause or movement, whether political, religious or other;
 - (f) contains copyrighted content (copyrighted articles, illustrations, images, lyrics, photos, audio, video, poems, text, or other content) without the express permission of the owner of the copyrights in the content;
 - (g) constitutes, promotes or encourages illegal acts, the violation of any right of any individual or entity, the violation of any local, state, national or international law, rule, guideline or regulation, or otherwise creates liability;
 - (h) discloses any personal identifying information relating to or images of a minor without consent of a parent, guardian or educational supervisor;
 - (i) infringes any copyright, trademark, patent, trade secret, or other intellectual property right;
 - (j) contains viruses or other harmful, disruptive or destructive files;
 - (k) harms or is inappropriate for minors to view;
 - (l) links to any commercial website; and
 - (m) is not otherwise in compliance with these Website Conditions.

6. AGE RESTRICTIONS

- 6.1. You affirm that you are either more than 18 years of age, or possess legal parental or guardian consent, and are fully able and competent to enter into the terms, conditions, obligations, affirmations, representations, and warranties set forth in these Website Conditions, and to abide by and comply with these Website Conditions.

7. FEES AND PAYMENT

- 7.1. The fees and charges for the use of the Services are available on our Website.
- 7.2. You acknowledge and agree that C 7 Traders, in its sole and absolute discretion, may now or in the future impose a fee or vary any fee for any Service.
- 7.3. In the event that any fee for any Service is stated erroneously on the Website or otherwise, as determined in the sole discretion of C 7 Traders, C 7 Traders:

- (a) is not obliged to provide the Service to you at the erroneous fee; and
- (b) shall be entitled to rectify such error by giving you written notice of the error and of the correct fee.

If you do not agree to make payment of the correct fee after being notified, you may terminate the Service and C 7 Traders shall refund any fees paid by you to C 7 Traders on a pro-rated basis for the remaining and unexpired portion of the term for such Service, as your sole remedy.

In the event that C 7 Traders terminates or withdraws the operation of any Service, you shall not be entitled to any refund of any fees that have been paid to C 7 Traders.

8. USER LICENSE GRANT TO C 7 TRADERS

- 8.1. You grant C 7 Traders, its affiliates, and related entities a royalty-free, perpetual, irrevocable, non-exclusive right and license to use, copy, display, archive, store, publish, transmit, perform, distribute, reproduce and create derivative works from all Content you provide to C 7 Traders in any form, media, software or technology of any kind now existing or developed in the future (the “**License**”). Without limiting the generality of the previous sentence, you authorize C 7 Traders to include the Content you provide in a searchable format that may be accessed by Users of the Services and other websites. You also grant C 7 Traders and its affiliates and related entities the right to use your name and any other information about you that you provide in connection with the use, reproduction or distribution of such Content. You also grant C 7 Traders the right to use the Content and any facts, ideas, concepts, know-how or techniques contained in any Content or communication you send to us for any purpose whatsoever, including but not limited to, developing, manufacturing, promoting and/or marketing products and services. You grant all rights described in this Clause 8.1 in consideration of your use of the Services without the need for additional compensation of any sort to you. This License will continue perpetually unless and until you remove your Content from the Website, at which time the License granted here will automatically expire.

9. CANCELLATION, TERMINATION AND SUSPENSION OF ACCOUNT(S) AND/OR SERVICE(S)

- 9.1. C 7 Traders shall be entitled at any time, at its sole and absolute discretion and without prior notice, to add to, vary terminate, withdraw or suspend the operation of the whole or any part or feature of the Website, Services, your Account and/or your access to all or any part of the Website or Services, for reasons including but not limited to:
- (a) breaches and/or violations of the Website Conditions and/or relevant agreements;
 - (b) to comply with the law or with legal process (such as pursuant to court order, sub poena, or a request by law enforcement officials);
 - (c) upon your request;
 - (d) extended periods of inactivity by a Account holder;
 - (e) engagement in fraudulent or illegal activities; and
 - (f) non-payment of fees and/or charges in relation to Services provided by C 7 Traders to you.

If, in future we use your Comments in promoting our website or in any other way, we will not be liable for any similarities which may appear from such use. Furthermore, you agree that we are entitled to use your Comments for any commercial or non-commercial purpose without compensation to you or to any other person who has transmitted your Comments.

11. NOTIFICATION OF INFRINGEMENT

- 11.1. C 7 Traders reserves the right to investigate notices of copyright, trademark and other intellectual property infringement (“**Infringement**”) in respect of C 7 Traders Content, User Content and other material on the Website (“**Infringing Material**”) and take appropriate action. If you believe that your work has been used or copied in a way that constitutes Infringement and such Infringement is occurring on this Website, please notify C 7 Traders in writing (“**Infringement Notice**”).
- 11.2. All Infringement Notices shall be sent to C 7 Traders addressed as in Clause 25 in these Website Conditions.
- 11.3. C 7 Traders will duly consider all Infringement Notices submitted in the above manner. In return, you agree that you shall not take any legal action or exercise any legal remedy you may have against C 7 Traders in respect of any Infringing Material, unless you have first given C 7 Traders the Infringement Notice and sufficient opportunity to remove the Infringing Material, and thereafter C 7 Traders refuses or fails to remove the Infringing Material within a reasonable time. Where C 7 Traders removes the Infringing Material in response to your Infringement Notice, you agree not to exercise and you hereby waive any right of action against C 7 Traders under applicable law which you may have in respect of any Infringing Material appearing on the Website prior to such removal by C 7 Traders.
- 11.4. You acknowledge and agree that C 7 Traders has no control and cannot undertake responsibility or liability in respect of Infringing Material appearing on Linked Sites or other third party sites.

12. INDEMNITY

- 12.1. You agree to indemnify and hold C 7 Traders, and its subsidiaries, affiliates, officers, agents, partners, and employees, harmless from all claims, demands, actions, proceedings, liabilities (including statutory liability and liability to third parties), penalties, and costs (including without limitation, legal costs on a full indemnity basis), awards, losses and/or expenses, due to or arising out of any use of the Website or any Service;
 - (a) your connection to the Website;
 - (b) your breach of any terms and conditions of these Website Conditions;
 - (c) your violation of any rights of another person or entity; or
 - (d) your breach of any statutory requirement, duty or law.

- 13.1. - 13.4. - 13.5. 16. JURISDICTIONAL ISSUES

- 16.1. C 7 Traders makes no representation that the Contents of the Website are appropriate or available for use in your location and country. Those who choose to access this Website from any location do so on their initiative and are responsible for compliance with local laws, if and to the extent local laws are applicable.

17. SEVERABILITY

- 17.1. If any provision of these Website Conditions is found to be illegal, void or unenforceable under any law that is applicable hereto or if any court of competent jurisdiction in a final decision so determines, these Website Conditions shall continue in force save that such provision shall be deemed to be deleted.

18. RELATIONSHIP OF PARTIES

- 18.1. Nothing in these Website Conditions shall constitute or be deemed to constitute an agency, partnership or joint venture between C 7 Traders and you and neither party shall have any authority to bind the other in any way.

19. WAIVER

- 19.1. No waiver of any rights or remedies by C 7 Traders shall be effective unless made in writing and signed by an authorised representative of C 7 Traders.
- 19.2. A failure by C 7 Traders to exercise or enforce any rights conferred upon it by these Website Conditions shall not be deemed to be a waiver or variation of any such rights or operate so as to bar the exercise or enforcement thereof at any subsequent time or times.

20. RIGHTS OF THIRD PARTIES

- 20.1. A person or entity who is not a party to this Agreement shall have no right to enforce any term of these Website Conditions, regardless of whether such person or entity has been identified by name, as an Account holder or as answering a particular description.

21. FORCE MAJEURE

- 21.1. No party shall be liable for any failure to perform its obligations under these Website Conditions if the failure results from a Force Majeure Event (defined below), provided always that whenever possible, the affected party will resume that obligation as soon as the Force Majeure Event occasioning the failure ceases or abates.
- 21.2. For purposes of this Agreement, a “**Force Majeure Event**” is an event which is a circumstance or event beyond the reasonable control of a party which affects the general public in that party’s country or in the territory, and which results in the party being unable to observe or perform on time an obligation under these Website Conditions. Such circumstance or event shall include industrial action or labour disputes, civil unrest, war or threat of war, criminal or terrorist acts, government action or regulation, telecommunication or utility failures, power outages, fire, explosion, natural physical disasters, epidemic, quarantine restrictions, and general failure of public transport

22. GOVERNING LAW AND JURISDICTION

- 22.1. These Website Conditions and all matters relating to your access to, or use of, this Website and Services shall be governed by and construed with the relevant laws and regulations, without giving effect to any principles of conflicts of law.
- 22.2. All disputes, controversies, or differences arising out of or in connection with these Website Conditions shall first be submitted to the Singapore Mediation Centre for resolution by mediation in accordance with the Mediation Procedure for the time being in force. C 7 Traders and you agree to participate in the mediation in good faith and undertake to abide by the terms of any settlement reached.

In the event that you and C 7 Traders are unable to resolve any dispute, controversies or differences after attempting mediation at the Singapore Mediation Centre, the dispute, controversy or difference shall be referred to and finally resolved by arbitration in Singapore in accordance with the Arbitration Rules of the Singapore International Arbitration Centre (“**SIAC Rules**”) for the time being in force, which rules are deemed to be incorporated by reference in this Clause 22.2.

23. ENTIRE AGREEMENT

- 23.1. These Website Conditions constitute the final, complete, and exclusive statement of the agreement of you and C 7 Traders with respect to the subject matter hereof, and supersedes any and all other prior and contemporaneous agreements and understandings, both written and oral, between you and C 7 Traders.

24. ENFORCEABILITY

- 24.1. If any portion of these Website Conditions is found to be void, invalid or otherwise unenforceable, then that portion shall be deemed to be superseded by a valid, enforceable provision that matches the intent of the original provision as closely as possible. The remainder of these Website Conditions shall continue to be enforceable and valid according to terms contained herein.

25. NOTICES

- 25.1. All notices, bills, invoices, or reports required by these Website Conditions shall be deemed to be received on (a) the day of delivery if delivered by hand during the receiving party's regular business hours or by facsimile before or during the receiving party's regular business hours; or (b) on the second business day following deposit in the originating post office, postage paid, to C 7 Trader's address below:
