




### Live Trading Competition - Terms and Conditions

1. C 7 Traders is running a Live Trading Competition (“Live Competition”).
2. For participating in this Live Competition, you have to register via the subscription link and be approved for a Trading account. All details provided during the registration process should be true; otherwise the participant/winner will be disqualified from the Live Competition.
3. By participating in the Live Competition, you acknowledge that you have read and agreed to be bound by these Terms and Conditions as well as to the Customer Agreement via the dedicated competition registration page.
4. Details of the registration and competition dates can be found in our website under the Trading Competition segment of the Promotion tab.
  - a. Clients must open a new account and make a single deposit of USD 500 to enter the Live Competition. No additional deposits are allowed thereafter.
  - b. Clients whom participated in our previous Live Trading Competition may use the same account for this competition. However, the account will have to meet the USD 500 requirement (Top-up if there is a shortfall; internal transfer if there is an excess).
  - c. Clients can only participate with a single account using one unique ID.
  - d. Clients cannot copy trade or run any form of automated trading (Including EAs) during this competition. If any trades are detected so, the participant/winner will be disqualified from the Live Competition.
5. Live Competition Structure and Award Prizes can be found in our website under the Trading Competition Segment of the Promotion tab.
  - a. For the purposes of the Live Competition, the winner will be awarded based on the profit percentage displayed in the Social Profile.
6. The Live Competition winner will be determined as the highest of the below figure.



The percentage figures measures the return on equity and is refreshed during server restart at midnight each day.

7. For the award prize to be added into the winner's trading account, the winner will have to:
  - a. Meet and must have already passed the C 7 Traders compliance procedures and checks; and
  - b. Provide a detailed report of his/her Live Competition account when and if requested by C 7 Traders.
8. The participant acknowledges and authorizes C 7 Traders to announce the results of the Live Competition on various Social Media or channels.
9. The trading accounts held by the clients for the Live Competition will not be entitled to receive any other promotion offered by C 7 Traders.
10. C 7 Traders will announce the winners within 30 days from the completion of the Live Competition.
11. By winning a Live Competition prize, the winners accept that they will participate in various promotional events that C 7 Traders can publicize freely on various venues. Promotional events include, but are not limited to, interviews, photos, listing announcement of their full names, nicknames, country of origin, prizes received, etc. In the event that the holiday package is not available, an equivalent cash amount will be awarded to the winner.
